#### A. Welcome

Board members Briana Stradinger, Vonda Apking, and Tami Richardson-Nelson were absent.

## D. Review of Agenda

Chairperson Meghann Cassidy reviewed the agenda with the Board Members.

## E. Acceptance of Agenda

Ms. Margie Propp moved to accept the agenda as written, seconded by Kim Davis. With no further discussion, the motion carried with all voting ayes.

#### F. Acceptance of Minutes

there were no changes suggested. Ms. Margie Propp made the motion to approve, and Meghann Cassidy seconded. With no further discussion, the motion carried with all voting ayes.

# G. Chairperson Updates (Meghann Cassidy, Chairperson)

- a. Intermediary application qualification review
  - Chairperson Cassidy asked Ms. Gina Petersen to elaborate on this agenda item.
    Ms. Petersen explained that the individual under review for intermediary
    licensure does not have an RID awarded certificate, meaning they need to
    submit the following qualifications listed in the rules and regulations and get
    approval by the full board.
  - Ms. Petersen mentioned number three on the rules and regulations sheet, pointing out that the individual must submit 8 hours' worth of training related to the role and function of a Deaf or Hard of Hearing Intermediary Interpreter, and this applicant completed training in protactile interpreting. Ms. Petersen voiced her uncertainty on whether protactile training counts towards such hours.
  - Chairperson Cassidy suggested taking a moment to review the qualifications submitted by the applicant.
  - Chairperson Cassidy noted that the protactile training certificates lacked any proof of interpreter specific training.
  - Ms. Davis informed the group that she counted only 7 out of the 8 required hours submitted for ethics, as one of the certificates of completion does not mention ethics.
  - Chairperson Cassidy shared her opinion that she does not think the requirements have been met.
  - Ms. Davis moved to suspend approval of the application until the applicant completes all required training hours, seconded by Ms. Propp.
  - There were no objections. The motion carried with all voting ayes.
- b. Canadian Certificate of Interpretation (COI) Review
  - Ms. Petersen shared that the group may need to drop consideration of acceptance due to specific verbiage in the rules and regulations.

#### Discussion on COI acceptance scenarios

- Chairperson Cassidy suggested denying acceptance of the COI, as it does not seem to fit within the rules and regulations
- Ms. Petersen mentioned checking with five states on whether or not they accept the COI none of them do.
- Ms. Propp moved that the IRB deny acceptance of the Canadian Certificate of interpretation, as it does not meet the requirements of the Nebraska Rules and Regulations. Chairperson Cassidy seconded.
- There were no objections. The motion carried with all voting ayes.
