


It is always a good idea to contact the therapist or the counseling office you are considering to verify whether they accept your insurance and determine any co-pay/sliding fee costs. Please check to see if they provide telehealth statewide if the counselor you are interested in is not in your area and determine their ASL level, experience working with deaf and hard of hearing individuals. Currently, providers that accept Medicare only are those who are psychiatrists, psychologists, clinical social workers and psychiatric nurses. Due to the Mental Health Access Improvement Act (S. 828/H.R. 432) of 2022, all other counselors and therapists will be able to register with Medicare to provide services to Medicare only individuals starting in 2024.
