E. Old Business

- a. Rules and Regulations Amended
 - i. Dr. Seiler reminded the members that the Full Commission Board has agreed to "grandfather" the QAST 4 and 5 holders for the proposed Rules and Regulations. Because of that and because the task force to review state certification has recommended that NCDHH drop state certification and only use RID certification for its licensure, Dr. Seiler shared that there are some changes to the rules and regulations language that needs changed to match this. Mr. Siders asked to clarify that the QAST testing will end in 2015 instead of 2014. Dr. Seiler explained that Kansas will stop creating

materials on 12/31/2014. He also explained that NCDHH has a new DVD test from Kansas Commission for the Deaf and Hard of Hearing that was purchased and never used. This video could be used for two years and thus allow people 2 years of QAST certification. This would create a transition period to assist interpreters to try RID certification or QAST 4 or 5. He stated that he plans to talk to the interpreter training programs in local colleges to discuss increasing the training provided in the program to help ready the students for higher levels.

ii. Dr. Seiler discussed that once QAST was no longer offered, there would no longer be a way for deaf persons to become Intermediary Interpreters unless they obtain Certified Deaf Interpreter from RID.
